



EVENT CONSENT, RELEASE, WAIVER AND INDEMNITY AGREEMENT

(Ontario, Canada)

PLEASE READ CAREFULLY BEFORE SIGNING

Voluntary Participation

I am attending this event voluntarily, for my own personal interest and enjoyment. I understand that I may leave the event at any time and that this event does not constitute a public show, adult entertainment venue, or any form of commercial performance.

Age of Majority

I confirm that I am at least nineteen (19) years of age, and I acknowledge that valid government-issued photo identification showing my date of birth may be required to verify my eligibility for entry.

Conduct and Consent

I understand that all participants are consenting adults engaged in private, lawful activity, and that all interactions must conform to the Rules and Guidelines provided in writing prior to the event. I agree that I will not engage in, encourage, or solicit any illegal or non-consensual acts. This includes, but is not limited to:

- Nudity, sexual conduct, or genital contact
- Prostitution or solicitation
- Non-consensual touching or harassment of any kind

All interactions must be consensual and respectful. I will not engage in any conduct with other attendees without their prior, explicit consent.

Prohibited Conduct

I understand and agree that the following behaviours are strictly prohibited:

- Bartering or attempting to barter with any model or participant
- Making false or misleading offers, including business or financial opportunities
- Using the event organizer's name or staff to influence models in any way
- Requesting or suggesting any activities beyond the permitted scope of foot-related interaction

Privacy and Confidentiality

I am not attending in any capacity as a journalist, investigator, or representative of any media, legal, or government entity. I will not record, photograph, publish, share, or otherwise disclose any details, images, or experiences from this event without the express written permission of the event organizer.

Prohibited Items and Substances

The possession, use, or distribution of illegal drugs is strictly prohibited. I understand that alcohol and cannabis use is also prohibited unless otherwise expressly permitted in writing by the organizer.

Non-Solicitation Agreement

I shall not solicit any models, staff, or guests for competing events, services, or parties that resemble or relate to the format, content, or clientele of the events hosted by the organizer. I further agree not to directly or indirectly solicit or interfere with any clients, models, or referral sources associated with the organizer during or after my attendance.

Photography and Devices

I understand that the use of cameras, cell phones, audio/video recording devices, or any similar equipment is strictly forbidden within the venue, unless otherwise permitted by the organizer. Cell phones may only be used in designated areas (e.g., lobby or exterior areas) as instructed.

Security and Access

I understand that all event play areas must remain unlocked and unobstructed at all times for safety and security reasons. I will not tamper with doors or access points in a way that compromises safety or privacy.

Compliance and Removal

I acknowledge that failure to comply with the event's Rules and Guidelines may result in my immediate removal without refund or recourse. I agree to review the Rules and Guidelines fully prior to participation and to abide by them in full throughout the event.

RELEASE AND WAIVER OF LIABILITY

I hereby release, discharge, and hold harmless the event organizers, including but not limited to Toronto Foot Party, its owners, agents, affiliates, volunteers, and representatives

(collectively, the “Released Parties”), from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury (including death), or expense that I may suffer or that may be caused in connection with my attendance or participation in the event.

This release shall be binding upon me, my heirs, legal representatives, and assigns.
